

## 1. Definitions

“Font Software” means coded software that generates typeface designs when used with the appropriate hard and software plus any and all other data including documentation provided with such software.

## 2. Grant of Licence

**2.1.** *Synergy Digital Media* grants you a non-exclusive, non-transferable licence to use the Font Software for your own personal or business purposes according to the terms of this Agreement.

**2.2.** You may embed the Font Software in documents, applications and devices. However, you may not distribute or make available the Font Software as such nor resell it.

**2.3.** Except as granted in 2.2., you may not modify, adapt, translate, reverse engineer, decompile, disassemble, alter, or attempt to discover the source code of the Font Software. If you want to make modifications to the Font Software, you must obtain the prior written consent of *Synergy Digital Media Group*.

## 3. Ownership

The Font Software, and all copies thereof, is protected by the United States Copyright Law, by the copyright and design laws of other nations, and by international treaties. In no event will *Synergy Digital Media Group* be liable to you for any consequential, incidental or special damages, including any lost profits or lost savings.

## 5. Governing Law

This Agreement will be governed by the laws of The United States. If any part of this agreement is found void and unenforceable, it will not affect the validity of the balance of the Agreement, which shall remain valid and enforceable according to its terms. You agree that the Font Software will not be shipped, transferred or exported into any country or used in any manner prohibited by the United States Export Administration Act or any other applicable export laws, restrictions or regulations. This Agreement may only be modified in writing signed by an authorized officer of *Synergy Digital Media Group*.

## 6. Termination

*Synergy Digital Media* has the right to terminate your licence immediately if you fail to comply with any term of this Agreement. Upon termination, you must destroy the original and any copies of the Font Software and Documentation.
